The living environment for foreigners has been significantly improved, especially in the three free economic zones of Incheon, Busan and Gwangyang, while comprehensive incentives, such as tax breaks, have been offered. More than a half of the world's top 500 corporations are already present in Korea.

The security situation on the Korean Peninsula will no longer constitute a stumbling block to your enterprise. Substantial progress has been made to resolve the North Korea nuclear problem at the fourth round of the Six-Party Talks of last month, and inter-Korean reconciliation and cooperation is livelier than ever.

When the road and rail network linking two Koreas is connected to the Trans-China Railroad and the Trans-Siberian Railroad, the value of investments in Korea as a logistics and business hub of Northeast Asia will be further increased. Inter-Korean economic cooperation projects, including the Gaeseong Industrial Complex, will provide you with further business opportunities.

Aside from all of the above, there is yet another reason why Korea is an attractive partner for cooperation. It is Korean entrepreneurs. Compared to those of the nations with a long history of industrialization, Korean entrepreneurs are far more willing to face challenges and highly motivated. To you who highly value trust and honor, they will prove to be very agreeable friends.

If Korea's technological expertise and excellent human resources can be combined with your capital and global network, the ensuing synergy effect will be quite substantial. Furthermore, we can possibly venture into the markets of other countries jointly. The Korean Government will do its best render support.
